Committee of the Whole Regarding September 11, 2023 Workshop Regarding Intersection of West Main Street/Stamfield Road/Experiment Farm Road. Mr. Lutz reported that the purpose of the workshop was to provide Council with the results of the consultant's study and recommendation for the construction of a roundabout at this intersection, with Council to provide feedback so staff would have direction as grant applications for some funding will be submitted yet this year. Council directed staff to continue with design, budget, and other work on a future roundabout. There will be future legislation related to this roundabout.
