SUBJECT: INCLUDING TROY SENIOR CITIZENS CENTER IN THE TEMPORARY DORA EXTENDED ACTIVATION AREA FOR THE 2026 TROY STRAWBERRY FESTIVAL/AMERICA 250 CELEBRATION CONCERT ON JUNE 6, 2026

### RECOMMENDATION:

That the Board of Park Commissioners provides a recommendation to Council that the property known as the Senior Citizens Center is included in the Temporary DORA extended activation area for future events to be considered on an event-by-event basis, to include the 2026 Troy Strawberry Festival/America 250 Celebration Concert on June 6, 2026.

### BACKGROUND:

Recognizing that 2026 is the 50<sup>th</sup> anniversary of the Troy Strawberry Festival (TSF), as a major event for the City's America 250 Celebration, the City is partnering with TSF to hold a concert on June 6, the Saturday evening of the Troy Strawberry Festival. Through an agreement with the Troy Board of Education, the concert will be held in the Troy Memorial Stadium. The Troy Board of Education is also agreeable to the City extending the Temporary DORA Activation Area to include the Troy Memorial Stadium.

The City will be requesting Troy City Council approval of an application to the Ohio Division of Liquor Control for a Temporary DORA Activation Area with Property Owners Permission as shown on the attached map in green. It is noted that this area includes the Troy Senior Citizens Center, which is recorded in the name of the Board of Park Commissioners. For mapping and enforcement purposes, it is simpler to have this area within this specific Temporary Activation Area than it would be to carve it out with an actual physical barrier. To be clear, the Senior Citizens Center area would not be part of any DORA without a recommendation of the Board of Park Commissioners to City Council and approval by City Council on an event-by-event basis.

### REQUESTED ACTION:

It would be appreciated if the Board of Park Commissioners would provide a recommendation to Troy City Council supporting the inclusion of the Troy Senior Citizens Center in the Temporary DORA Extended Activation Area boundary for June 6, 2026 for the Troy Strawberry Festival/American 250 Celebration Concert.
