A **Post CRA Application** will be required to be submitted when the project is completed. This application can be obtained on the City of Troy's website: <https://www.troyohio.gov/133/Community-Reinvestment-Area-Program> or picked up from Troy City Hall Development Department on the first floor located at 100 S. Market Street. At that time, the following information will be required to be submitted to the City of Troy's Development Department.

- i. Project description including reason requesting tax incentive
- ii. Copy of the Miami County Development Certificate of Occupancy (if applicable) and Building Permit
- iii. Copy of Troy Zoning Permit (if applicable)
- iv. Copy of documentation showing the cost of improvements
 - a. Spreadsheet of expense summary
 - b. Evidence of expenses (contracts, invoices, cancelled checks, etc.)
(Note: Labor completed by the property owner cannot be included into the project costs)
 - c. Notarized Certification of Improvements

The period of exemption starts in the tax year following the completion year after it is certified to the County Auditor. The deadline to submit the Post CRA Application with all the required supporting documentation to the Troy Development Department is **June 1st each year** for exemption to begin in January; otherwise, the tax exemption will begin in July of the following year.
